<b>W.5.1</b>	<ul style="list-style-type: none"> <li>Write opinion, persuasive, and position pieces on topics or texts, supporting a point of view with reasons and information.</li> </ul>
<b>W.5.1a</b>	<ul style="list-style-type: none"> <li>Introduce a topic or text clearly, state an opinion, and create an organizational structure in which ideas are logically grouped to support the writer's purpose.</li> </ul>
